SUMMARY CASE.

(Under Receiving Order dated the 2nd day of January, 1911, on Debtor's Petition.)

NOTICE IS HEREBY GIVEN that the **FIRST MEETING** of Creditors in the above matter will be held at the **Official Receiver's Office, 68a, Castle Street, Canterbury**, on the 21st day of January, 1911, at 9.15 o'clock in the forenoon.

The Debtor has been adjudged bankrupt, and an Order for Summary Administration has been made by the Court. Under Section 121 of the Bankruptcy Act, 1883, the Official Receiver is the Trustee in the Bankruptcy; but the Creditors can, by Special Resolution, appoint a Trustee in his place.

To entitle you to vote thereat your **PROOF** must be lodged with me not later than 12 o'clock on the 20th day of January, 1911.

A form of Proof and forms of General and Special Proxy are enclosed herewith. **PROXIES** to be used at the Meeting must be lodged with me not later than 4 o'clock on the 20th day of January, 1911.

The **PUBLIC EXAMINATION** of the Debtor is fixed for the 21st day of January, 1911, at 10 o'clock in the forenoon, at the **Guildhall, Canterbury**.

Any Creditor who has tendered a proof, or his representative, authorized in writing, may question the Debtor on his Public Examination concerning his affairs and the causes of his failure.

CAUSES OF FAILURE AS STATED BY THE DEBTOR.

"Insufficient income to meet necessary expenses, owing to non-receipt of monetary assistance which I generally relied upon."

THE OFFICIAL RECEIVER'S OBSERVATIONS.

1. The Receiving Order was made on the petition of the Debtor, and he was adjudged bankrupt the same day on his own application.

2. The Debtor (aged 60 years) who had for many years practised as a Surgeon Dentist in London, states that he was advised—owing to ill-health of his Wife—between 11 and 12 years ago to remove from London and reside at the seaside. He thereupon relinquished his practice and went to reside at Brighton for about three years, and afterwards (about seven years ago) he removed to his present address. The Debtor further states that he has had no occupation or profession since he left London, as his Wife has separate estate, and he has been dependent upon her and his relatives for means of subsistence. All the liabilities are apparently due to local tradesmen, and contracted during the last two or three years. The Debtor also states he had hoped to discharge these bills with the assistance of his relatives and friends, inasmuch as his Wife's income had all been absorbed in discharging other household expenses. He alleges that he did not discover his insolvency until about six or eight months ago, when he realized his friends were not disposed to assist him further. It will be seen that the Debtor's Statement of Affairs discloses no assets. The furniture at his residence is claimed under a Bill of Sale executed several years ago. The Debtor contends that he is quite unable to file any reliable deficiency account.
